If yes, kindly provide me the details of circulars, notices, letters, date of intimation/clearance etc. in this regard if so issued by your company or by the **HARYANA VIDYUT PRASARAN NIGAM LTD.(HVPNL)** with reference to their proposed projected line i.e. **132Kv Tajpur to Begga single circuit Line of 0.4 sq**".
2. Whether the aforesaid proposed projected line i.e. **132Kv Tajpur to Begga single circuit Line of 0.4 sq** had submitted any layout plan for the above said clearance with your good self ?if yes kindly provide me details in this regard.

5. Whether, at any point of time, the intersection point of these two lines changed during the installation of the said line (**132Kv Tajpur to Begga Line**)? If yes, then kindly provides the details of the same.
