Sub: Reimbursement of cost of mobile phone facility- Modification thereof.

- 1.0 Keeping in view the technological advancement in mobile instruments, it has been decided to revise the ceiling limit for reimbursement of cost of mobile instrument (including taxes) for Workmen & Supervisor from existing amount of Rs. 3000/- to Rs.5000/-.
- 2.0 The cost of mobile instrument purchased by the employee shall be reimbursed on production of bill/ cash memo within the above ceiling limit.
- 3.0 Employees who have already been reimbursed the cost of mobile instrument shall be eligible for above revised amount only on completion of life span of 02 year period. The claims already processed/ paid shall not be reopened.
- 4.0 The amount of revision of mobile instrument comes into force w.e.f. 01.04.2017.
- 5.0 All other terms & conditions of the scheme shall remain unaltered.

Subject :Scheme of Mobile Phone Facility for Employees in Workmen & Supervisory category- Modification thereof.

1.0 It has been decided by the Management to revise the monetary ceiling of reimbursement of cost of mobile instrument and communication expenses for employees in Workmen & Supervisory as under:

a) Reimbursement of mobile instrument.

Grade	Ceiling once in 02 years (excluding all taxes)
W0 to W6	Rs. 8000.00
W7 to WSG	Rs. 10000.00
All Supervisors	Rs. 11000.00

b) Reimbursement of Communication expenses.

Official call charges (Entitlement per month) (call charges + rental of mobile, landline at residence, broadband (including rental) and data card service (including rental) subject to actual and financial year ceiling limit, excluding all taxes)	
Grade	Adjustable within an annual ceiling limit of :
All Workmen	Rs. 10000.00
All Supervisor	Rs. 11000.00

c) Reimbursement towards cost of mobile battery charges stands deleted.

d) All other terms & conditions of Scheme of providing mobile phone facility to non- executive shall remain un-changed.

2.0 Employees who have already availed the reimbursement of communication items shall be entitled for revised amount mentioned above only after the lapse of two years. Mere change in entitlement on account of change in level, before completion of stipulated life period of communication items would not entitle an employee to change the communication items.



3.0 Reimbursement of cost of communication items within the above ceiling limit by the employees shall be made on submission of bill/ cash memo.

4.0 The above revision shall come into force w.e.f 01.04.2019.

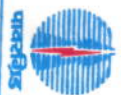
