Now, on going through the contents of RTI Application dt.13.06.2019 and Appeal dt.06.08.2019 and the information furnished/provided by CPIO, POWERGRID, NR-I vide letter No. POWERGRID/NR-I/RTI/1780/2386 dt.16.07.2019 and letter No.POWERGRID/NR-I/RTI-Appeal/1769/3294 dt.03.09.2019 it is emerged that as the information sought by you comes under the exemption criteria of Section 8(1) (d), (e) & (j).
