Subject:-First Appeal against the information dated 29-11-2019 provided by chief Information Officer, Power Grid Corporation of India

Sir,

With due respect, it is to be informed that Applicant vide his application dated 29.10.2019 sought the following information from the office of Chief Information Officer:-

"That a high tension line was drawn by the department through Applicant's land bearing chak no. 173 situated at village Chudiyawala Mohanpur, Tehsil Roorkee, Pargana Bhagwanpur, District Haridwar, Uttarakhand between Tower no. 031/RRK-SRE and 032/RRK-SRE High Tension line and compensation for the damages is still not paid to the Application. The reason why the applicant still not compensated or whether the compensation is awarded to some other co-owner of chak no. 173 if yes, the details of such compensation awarded and on the guidelines or basis of such award." Applicant being recorded co-owner of the land along with Application furnished revenue record wherein Applicant is duly recorded owner of the land bearing chak no. 173 Khasra no. 445/2, 447/1 & 447/3 area 0.479 Hec.

The Chief Information Officer vide letter dated 29-11-2019 supplied the incomplete information which is being filed alongwith this appeal. The Chief Information Officer failed to disclose the amount of compensation awarded to the recorded owner whose land was taken for the work and further despite submitting the revenue record and further failed to satisfy or acknowledge why compensation was not duly given to the applicant though Applicant is recorded owner of the land in question.

Sir, with due respect, it appears that your subordinates in collusion with other co-owner distributed compensation in files only as till date not a single penny has been given to me despite of the


fact that my land is been utilized by the department. Hence I am entitled to the information and details sought under the RTI Act as well as on administrative side also being deprived of my land.

Therefore is humbly prayed that cognizance of my Appeal may very kindly be taken and requisite information regarding the details of payment of compensation as well as amount and on the basis of the compensation awarded, may very kindly be given to the Appellant.


