ORDER

The Appellant **Shri Anil Kumar Tyagi C/o Nirmata Architects, Hotel HIM Palace (Basement Floor), Haridwar Road Dharampur, Dehradun-248001 Mobile No.9412050996** vide his RTI Application Dt.29.10.2019 had requested for furnishing certain information under the Provisions of Right to Information Act-2005. CPIO, NR-I has furnished information as per the provisions of RTI Act-2005 vide his letter No.POWERGRID/NR-I/RTI/1817/5123 Dt.29/02.12.2019.

Now first RTI Appeal u/s 19(1) of the RTI Act, 2005 has been filed by Shri Anil Kumar Tyagi vide appeal dt.12.12.2019 in the office of undersigned and the same is received on 17.12.2019. In his appeal, Appellant Shri Anil Kumar Tyagi has mentioned that CPIO failed to disclose the amount of compensation awarded to the recorded owner and also failed to satisfy or acknowledge why compensation was not duly given though the applicant is recorded owner of the land in question.

On going through the contents of RTI Application dt.29.10.2019 and Appeal Dt.12.12.2019 vide which the information sought by the appellant it is found that CPIO NR-I has already provided the information vide letter No.POWERGRID/NR-I/RTI/1817/5123 Dt.29/02.12.2019 as per the provisions of RTI Act-2005.

Now it is further intimated that on receipt of your appeal the matter was again forwarded to the concerned office of POWERGRID. In this regard it is intimated that the compensation cannot be given on the basis of Chak Number. As none of your crop and tree has been damaged and accordingly verification by the concerned revenue office has not been done, in this case you are not eligible for the payment of compensation. Therefore, the appeal is disposed-off.
