ORDER

The Appellant **Shri Duli Chand S/o Shri Lala Ram Mahawar, Gram, Purana, Bagrana Post Kanota, Agra Road, District Jaipur(Rajasthan)** vide his RTI Application Dt.27.11.2019 had requested for furnishing certain information under the Provisions of Right to Information Act-2005. CPIO, NR-I has furnished information as per the provisions of RTI Act-2005 vide his letter No.POWERGRID/NR-I/RTI/1821/5836 Dt.02.01.2020.

Now, first RTI Appeal dt.24.01.2020 u/s 19(1) of the RTI Act, 2005 has been filed by Shri Duli Chand in the office of undersigned, which is received on 29.01.2020. In his appeal, the appellant Shri Duli Chand has mentioned that he is not satisfied with the information/documents provided by CPIO due to non-providing of attested copies of the documents. CPIO NR-I initially has not provided the attested copies of the documents mentioned in his letter No.POWERGRID/NR-I/RTI/1821/5836 Dt.02.01.2020 because the original letters and FAA order has already been provided to the Appellate.

Ongoing through the contents of RTI Application dt.27.11.2019 and Appeal Dt.24.01.2020 vide which the information sought by the appellant it is found that CPIO NR-I has already provided the information vide letter No. POWERGRID/NR-I/RTI/1821/5836 Dt.02.01.2020 as per the provisions of RTI Act-2005.

As required, CPIO, NR-I has already provided the attested copies of the documents to appellant vide letter No.POWERGRID/NR-I/RTI/1821/6629 dt.05.02.2020. Hence the information desired by the appellant stands provided and the appeal is disposed-off.
