ORDER

The Appellant Shri Duli Chand S/o Shri Lala Ram Mahawar, Gram Purana Bagrana, Agra Road, Distt. Jaipur(Rajasthan) (श्री दुलीचंद पुत्र श्री लालाराम महावर, ग्राम पुराना बगराना आगरा रोड, जिला जयपुर (राजस्थान) vide his RTI Application dt.25.09.2018 had requested for furnishing information regarding action taken report on letter dt.09.07.2018 under the provisions of Right to Information Act-2005. CPIO, NR-I, Power Grid Corporation of India Ltd., B-9, Qutub Institutional Area, Katwaria Sarai, New Delhi-110016 vide his letter No.POWERGRID/NR-I/RTI/1667/5077 dt.01.10.2018 has intimated to Shri Duli Chand that letter dt.09th July-2018 could not be received. Otherwise as matter already known information regarding payment of EMD i.e. Rs.26400/- has already been given by CPIO, POWERGRID, NR-I.

Now, first RTI Appeal dt.04.02.2019 u/s 19(1) of the RTI Act, 2005 has been received in the office of undersigned on 07.02.2019. In his appeal, the Appellant Shri Duli Chand has mentioned as CPIO, POWERGRID, NR-I has informed that letter dt.09.07.2018 has not been received in this regard the appellant has inquired the matter with the Postal Department. Letter No.PG/RTI/08/2018 dt.08.01.2019 issued by CPIO, Office of the Chief Postmaster General, Rajasthan Circle, Jaipur-302007 intimating that the Article No.RR163913109IN dt.09.07.2018 has been delivered to POWERGRID Katwaria Sarai, New Delhi. Subsequently the matter has been referred again to CPIO, POWERGRID, NR-I for furnishing the information accordingly.

Now, CPIO POWERGRID, NR-I has informed that the matter has again looked after and it is found that the letter dt.09.07.2018 could not reached to the concerned dealing person of RTI, it is misplaced anywhere in the documents inadvertently. In this regard CPIO has written a letter No.POWERGRID/NR-I/RTI/1667/7689 dt.08.02.2019 to Shri Duli Chand (Appellant) but the said letter could not be delivered due to problem of recipient at the address(Copy of Envelope enclosed) and returned back to POWERGRID New Delhi on 27.02.2019.

Accordingly, from the office of CPIO, POWERGRID, NR-I telephonic conversation on Mobile No.9928084113 has also been made with Shri Duli Chand (Appellant) on 27.02.2019 and 06.03.2019 regarding providing a copy of letter dt.09.07.2018 so that the action can accordingly be taken on the contents of letter dt.09.07.2018. But copy of letter dt.09.07.2018 has not been provided by you till date.
