**ORDER**

The Appellant **Shri Balbir Singh S/o Shri Hari Singh, Village Jaurasi Khas, Tehsil Samalkha, Distt. Panipat, Haryana** vide his RTI Application Dt.19.11.2019 had requested for furnishing certain information under the Provisions of Right to Information Act-2005. CPIO, NR-I has furnished information as per the provisions of RTI Act-2005 vide letter No.POWERGRID/NR-I/RTI/1820/5983 Dt.03/07.01.2020.

Now, first RTI Appeal dt.24.01.2020 u/s 19(1) of the RTI Act, 2005 has been filed by Shri Balbir Singh in the office of undersigned (received on 28.01.2020). In his appeal, the appellant has mentioned that information provided by CPIO is incomplete and felt his dissatisfaction with the information provided.

Ongoing through the contents of RTI Application dt.19.11.2019 and Appeal Dt.24.01.2020, it is found that CPIO NR-I has already provided the information vide letter No.POWERGRID/NR-I/RTI/1820/5983 Dt.03/07.01.2020 as per the provisions of RTI Act-2005.

Further, CPIO, NR-I has again been directed by the undersigned to provide the information as desired by the appellant. CPIO, POWERGRID, NR-I has provided the information as per the provisions of RTI Act-2005 vide letter No.POWERGRID/NR-I/RTI/1820/7363 dt.09.03.2020. Hence it is concluded that the information sought by the appellant is of the period from 2001 to 2005, the information which is available has been provided by CPIO as per the provisions of RTI Act-2005 and appeal is disposed-off.

It is to inform that the queries raised by yourself through RTI pertains to a very old period from 2001 to 2005. Most of the records of this period are generally not available. However based on some available records the point-wise information is being provided:

3. **Information to Point No.4:** Compensation Payment as mentioned by you in your RTI application has been made to Shri Hari Singh through Cheque. Information and receipt in this regard cannot be provided as per Section 8(1) (j) of RTI Act.
4. **Information to Point No.5:** As already informed, the information regarding payment made to a third party cannot be provided under section 8(1) (j) of the RTI Act-2005.
