
This has reference to letter No.SDM/KH/(SW)/2020/9500 dt.10.02.2020 of Shri Rajender Kumar, APIO/Tehsildar (Kapashera) vide which point No.5 and 6 of RTI application dt.04.09.2017 was forwarded for furnishing of information. Shri Rajender Kumar, APIO/Tehsildar Kapashera has forwarded the letter on the direction issued by Hon'ble Central Information Commission, Delhi vide Order file No.CIC/ADDDM/A/2018/119656 dated 20.12.2019. The information against Point No.5 & 6 is as follows:

Information to Point No.5 & 6: As per records, no high tension pole was erected on the above property. However, conductors are passing over the above properties. No compensation (for stringing) was paid to any bhumidar of Khata No.44, 45 and 78 (Khasara No.9/17, 18, 19, 22, 23, 24, 25, 9/4, 5, 26, 23/22, 23, 24 and 30/1, 2, 3).

As no Khata No. were recorded in our records only Khasara numbers were recorded on crop compensation form hence the khasara numbers provided 'Khatauni Consolidation' were checked in our records for above purposes. Accordingly the above information is being furnished.
