It is to mention that while travelling from phalodi office to Bhadla 2 s/s site on date 21/3/2020 in morning on office vehicle, Emp No-60001346, Mr, R.P. Sagar tried to impose physical and mental assault on me and also threatened to kill me by saying ("Yahi Dafan Kar Dunga ") . Total persons travelling on the vehicle were 7 (including driver) .

Mr. Ram Prasad. sagar was consistently threatening driver of the vehicle to overtake front moving trucks, even though road was crowded busy with excessive traffic coming from opposite lane. I asked Mr. sagar not to pressurise driver and let driver take the decision as per his driving expertise. In return Mr. Ram Prasad sagar launched physical and mental assault along with death threat on me.
