**Shiv Kumar vs. CPIO, Power Grid Corporation of India Limited, New
Delhi**

ORDER

1. The appellant filed an application under the Right to Information Act, 2005 (RTI Act) before the Central Public Information Officer (CPIO), Power Grid Corporation of India Limited (PGCIL), New Delhi, seeking information on 17 points pertaining to the distribution of compensation awarded by the respondent to him and his brother, Shri Sujan Singh for installation of Baghat-Dehradun transmission line, including, inter-alia (i) the reasons for payment of compensation to Shri Sugam Singh for removal of trees growing on the appellant's land and for not rectifying the error committed, and (ii) the dimensions of the area, taking location no. 22/4 or 22/3 as a base, for removal of trees.

2. The appellant filed a second appeal before the Commission on the grounds that incomplete information has been furnished to him by the CPIO. The appellant requested the Commission to direct the CPIO to provide complete and correct information to him, free of cost, and to impose penalty upon the CPIO.

Red

Hearing:

3. The appellant Shri Shiv Kumar and the respondent, Shri B.P. Saraswat, Chief Manager and Shri Rajender Prasad, Sr. P.S., Power Grid Corporation of India Limited, New Delhi, were present in person.
4. The appellant submitted that the respondent, inter-alia, has not provided the exact location/measurement as well as the photograph of the area from where trees were removed, taking location no. 22/4 or 22/3 as a base, as per the Google maps. Moreover, the CPIO had not provided the copy of the notice issued in respect of location no. 22/3 and 22/4 for removal of trees on the said land under point no.2 of the RTI application. The appellant further submitted that no reasons have been given to him as to why compensation has been paid to his brother, Shri Sugam Singh, for trees removed from the former's land.
5. The respondent submitted that point-wise information as per the available records has been provided to the appellant vide letters dated 28.12.2016 and 13.02.2017. The respondent further submitted that there is a land dispute between the appellant and his brother Shri Sugam Singh and the Corporation has no role to play in that dispute. Moreover, the appellant is seeking redressal of his grievance/complaint pertaining to compensation awarded to his brother for trees removed from the appellant's land. However, the RTI Act is not the proper law for redressal of grievances and there are other appropriate fora for resolving such matters.
6. The respondent agreed to provide the copy of the notice under point no. 2 of the RTI application to the appellant at the time of hearing itself.

Decision:


7. The Commission, after hearing the submissions of both the parties and perusing the records, observes that the information sought by the appellant is clarificatory in nature, which is not covered under the scope of RTI Act. Nonetheless, an appropriate, point-wise, reply has been furnished to the appellant. The Commission also accepts the stand of the respondent

that the RTI Act is not the proper law for redressal of grievances and that there are other appropriate fora for resolving such matters. The Commission, however, directs the respondent to provide a copy of the notice as sought, vide point no. 2 of the RTI application, to the appellant within a period of four weeks from the date of receipt of a copy of this order.

8. With the above observations, the appeal is disposed of.
9. Copy of the decision be provided free of cost to the parties.
