As per the reply only an amount of Rs. 10,64,375/- has been processed by Power Grid in my name. But the total amount received is lot more than that. I have received a check with the mentioned amount, along with other checks of different amounts. As per the rules total amount of money processed for this khasra number must be divided equally between the owners. I want to know if the rule has been followed. Subsequently, CPIO has provided information to appellant Shri Balraj Singh vide letter No.POWERGRID/NR-I/RTI/2069/3717 dt.13.12.2021(copy enclosed).

Keeping in view the above discussion, it is emerged that the information which can be provided under the provisions of RTI Act, 2005 has been provided by CPIO, POWERGRID, NR-I. Hence, the appeal is disposed-off.
