**ORDER**

The Appellant **Shri V.K.Gaur, House No.C-115, Gali No.8, Kanti Nagar, Extn., Delhi-110051** vide his RTI Application Dt.16.12.2021 had requested for furnishing certain information under the provisions of Right to Information Act, 2005. CPIO, NR-I has provided information as per the provisions of RTI Act-2005 vide his letter No.POWERGRID/NR-I/RTI/2080/3889 Dt.29.12.2021.

Now, first RTI Appeal Dt.14.01.2022 (received on 17.01.2022) u/s 19(1) of the RTI Act, 2005 has been filed by Appellant Shri V.K.Gaur in the office of First Appellate Authority/E.D.(NR-I). In his appeal, the appellant has mentioned that the information provided by CPIO is baseless, illusive. He has also mentioned in his appeal that CPIO has tried to conceal the facts.

Ongoing through the contents of RTI Application dt.16.12.2001, Appeal Dt.14.01.2001 and subsequently the submission of CPIO, POWERGRID, NR-I has been heard. On going through the contents of Appeal Dt.14.01.2022, CPIO, POWERGRID, NR-I has again been directed to look into the matter again and take the opinion of the concerned Department and provide information as per the provisions of RTI Act, 2005. Accordingly Finance Department of NR-I intimated that action taken report and final decision of Competent Authority on letter Dt.01.12.2021, it is once again reiterated that the decision taken by NR-I Finance and NR-I HR Department was upheld by Corporate Centre. The said decision has been communicated to Shri V.K.Gaur on 22.10.2020 and again on 21.12.2021 in response to his letter Dt.01.12.2021.

Now, on going through the above discussion, it is to concluded that the information which should be provided as per the provisions of RTI Act, 2005 has been provided. Hence, the appeal is disposed-off.
