
**ORDER**

The Appellant **Shri Jagdish Singh**, House No. A153, Saraswati Enclave, Near Sector 10A, Gurugram, Haryana-122001 vide his RTI application Dt.10.03.2022 had requested for furnishing certain information under the Provisions of Right to Information Act-2005. The RTI application was addressed to CPIO, CC Gurugram and the same is received in the office of CPIO, POWERGRID, NR-I through POWERGRID, RTI Portal on 21.03.2022. On going through the Contents, CPIO, POWERGRID, NR-I forwarded the RTI application to CEO of POWERGRID Khetri Transmission System Limited as the contents on which the information sought is pertains to them.

Subsequently vide letter No.PKTSL/RTI/22/ Dt.13.04.2022 (Dispatched on 19.04.2022) and e-mail Dt.19.04.2022 at about 10:25, point wise information has already been forwarded to Shri Jagdish Singh.

Now, first RTI Appeal Dt.14.04.2022 u/s 19(1) of the RTI Act, 2005 has been filed by Appellant before First Appellate Authority CC, Gurugram. Accordingly appeal has been received through POWERGRID Appeal Portal on 22.04.2022 in the office of undersigned. In his appeal, appellant has mentioned that the respondent has not provided the information.

Therefore, keeping in view the above discussion, it is to intimate that point-wise information as per the provisions of RTI Act, 2005 has already been provided on 19.04.2022. Hence, the appeal is disposed-off.
