First appeal under section 19 (1) of the R. T. I. Act, 2005, against respondent for not providing the information sought through application dated 10/03/2022, moved under section 6 (1) of the R. T. I. Act, 2005.

Sir,

Appellant most respectfully and humbly submits as under:-

1. That appellant is a citizen of India and has legal right to get information from any public authority under the Right to Information Act, 2005.
2. That office of the respondent falls within the purview of public authority and is legally bound to provide information sought under The R. T. I. Act, 2005.
3. That an application dated 10/03/2022, seeking information under section 6 (1) of the R. T. I. Act, 2005, was moved to the respondent through speed post vide postal receipt number EH282846047IN dated 10/03/2022, issued by post office Gurugram, Haryana.
4. That required fee of rupees ten in the form of **Indian Postal Order** bearing number 53F 444939, issued by post office Gurugram, Haryana,

on dated 12/02/2022, was attached with the RTI application dated 10/03/2022.

5. That subject matter of the information is that applicant is permanent resident of village KHERA-PATAUDA, Tehsil & District Jhajjar, Haryana and is co-owner of land having *Killa* No. 190/4 & 190/5; falling under the revenue estate of village *KHERA- PATAUDA*, Block-Maachhrauli, Tehsil & Distt. Jhajjar, Haryana. Power Grid Corporation of India has completed its project of 765/400 KV, TRANSMISSION LINE from KHETRI TO JHATIKARA. Transmission line has been crossed over the Killa No. 190/4 while pole number KHT-JTK- 0301, has been installed in Killa No. 190/5. Department has paid Rs. 1306/- only regarding killa number 190/4 while despite complaint dated 07/9/2021, nothing has been paid to the applicant so far. Copy of this letter dated 07 September, 2021 is attached for perusal. Information is concerned with the same subject.

Sought information is as under:-

- a) Provide the details of steps taken by the department on the letter dated 07/9/2021 moved by the applicant to the department situated at Sector 4, Rewari, Haryana.
 - b) Provide complete details of the reasons for not providing the compensation regarding killa number 190/5 in which pole number KHT-JTN 0301. has been installed.
 - c) Provide the reasons for paying only Rs. 1306/- regarding land killa number 190/4 while minimum compensation of Rs. 21000/- has been paid to the other owners of land for the same work.
 - d) Provide the time-frame for the completion of process of compensation regarding aforesaid both killa numbers, 190/4, 190/5.
6. That as per Indian Post Tracking Report, item booked at Gurugram, through postal receipt number EH282846047IN dated 10/03/2022, has been shown delivered on dated 12/03/2022. Thirty two days have passed when the item has been delivered on dated 12/03/2022 but nothing has been provided by the CPIO so far.
7. That as per Sub Section 2 of Section 7 of the RTI Act, 2005; If the Central Public Information Officer or State Public Information Officer, as the case may be, fails to give decision on the request for information within the period specified under sub-section (1), the Central Public Information Officer or State Public Information Officer, as the case may be, shall be deemed to have refused the request.



Hence, this first appeal is preferred. Kindly consider my first appeal as per provision of the Right to information Act, 2005. I shall be very thankful to you for this kind obligation.

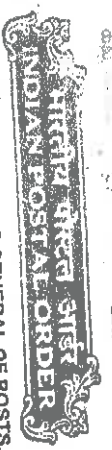

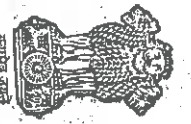

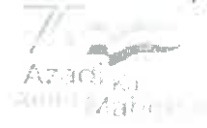
