This has reference to your Online RTI Application Registration Number PGCIL/R/E/23/00039 Dt.19.01.2023 vide which information under RTI Act has been sought by yourself against Point No.1 to 5. The said RTI is filed with respect to 765kV D/C Sikar-II-Aligarh T/L and Guidelines issued vide No.3/7/2015-Trans by Government of India, Ministry of Power, Shram Shakti Bhawan, Rafi Marg, New Delhi-110001 Dated 15.10.2015.

In this reference, it is to intimate that 765kV D/C Sikar-II-Aligarh T/L is under Power Grid Aligarh Sikar Transmission Line (A 100% wholly owned subsidiary of Power Grid Corporation of India Limited). Point-wise information is as under:
