Subject: Regarding RTI Application Dt.05.06.2023 under RTI Act-2005.

Sir,

This is in reference to your RTI application Dt.05.06.2023 vide which information against Point No.3 (A) and (B) have been sought by you under RTI Act, 2005. On going through the records, it is found that RTI application dt.26.04.2022 on the same contents had already been filed by you in POWERGRID.

Vide letter No.POWERGRID/NR-I/RTI/2138/1293 Dt.31.05.2023, it has already been intimated that ***“the information sought by you is very vast and voluminous in nature and comes under the exempted clauses of RTI Act, 2005. The information sought by you does not justify the larger public interest or activity. Besides this, by adhering to the spirit of the provisions of RTI Act you have been allowed for inspection of documents at POWERGRID Manesar Office as per clause 2(j) (i) of RTI Act, 2005”***. Now matter is discussed with the concerned office of POWERGRID and it is known that to date you have not visited POWERGRID Manesar office.

Now, in continuation to this on going through the contents of RTI application Dt.05.06.2023, it is to intimate that the information sought by you is exempted under clause 8(1) (d) of RTI Act, 2005.

Besides this as mentioned in letter dt.31.05.2023, you can again be allowed to inspect the available documents/records at POWERGRID Manesar Office and copies of the allowable documents can be obtained on making payment as per the provisions of RTI Act, 2005.
