
Sir,

This is with reference to your reply N2JM- 8252 dated 17-12-2013 **Regarding Installation of Electric Tower (POWER-GRID JHK-ABD 0144) Installed at Khasra No. 339, Khewat No. 28/25, Khatauni No. 66/63, measuring 00-08-93 hect. As per point No. 1 you have informed that as per general practice of Power Grid land is not acquired for construction of transmission line. In this regard it is informed that the valuable land of the poor farmer has been taken away for erection of the aforesaid line without compensating the aforesaid farmer. You are therefore requested to disclose name of the agency who was supposed to acquired this land. In case no reply is received within 15 days the matter shall be taken before The Hon'ble High Court by invoking the Writ Jurisdiction for claiming the compensation worth Rs. Fifteen Lacs only.**
