In this regard i submit my grievance on 30th May 2014. Case no:- ROCHN/E/2014/00609 at EPFO Chandigarh. Before this i consistently inquire the matter from EPFO chd. But no solution. Now yesterday i guess after heard a call from EPFO Chandigarh that Power Grid have not submit your father Nomination forms of EPS-95.

Therefore i hereby requested you to supply my father last filled nomination forms before his death. As per my information he filed on 13-07-2009 in Patiala sub-station with myself declared his only nominee for EPS-95 family pension scheme. So i was eligible to get nominee pension from his age attaining 58 years i.e year 2009.

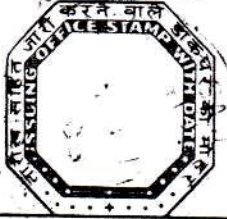
