1. We are/were 5 sons of Late Sh.JugLal, and my brothers name are (i) Late Sh.Kehar Singh (ii) Sh.Chotte Ram (Myself) @ Chhotu @ Chhote Lal (iii) Sh.Ram Singh (iv) Late Sh.Subhe Singh & (v) Sh. Lakhmi Chand. All the brothers are cultivating their Agriculture land since last 40 years with mutual understanding.
2. I, Chotte Ram @ Chhotu @ Chhote Lal S/o Late Sh.JugLal, aged about 95 years, Resident of Village Tihar Malik, Tehsil Gohana, Distt. Sonapat (Haryana). My Sons namely Dr. Umed Singh Malik, Sh.Kartar Malik & Sh.Azad Singh are in Govt. service posted at Chandigarh / Panchkula and residing in Chandigarh & Panchkula and me & my wife Smt.Kuria Devi, aged about 90 years also living with them.
3. I had given my 13 Bighas Agriculture land in Khewat No.51 Min.No.4 & 7, Khewat No.47 , Min No.24 & 25/2 for removal of earth approx.by two and half feet deep for the purpose of bricks making @ Rs.50,000/- per acre to M/s B.R.Bhatha Company of Village Tihar Malik, Tehsil Gohana, Distt. Sonapat (Haryana) on 24.04.2010. An Agreement was made from 24.04.2010 to July, 2012 between both the parties (Photo Copy of Affidavit to the effect and receipt for Rs.2,60,000/- are enclosed). The above said Agriculture land has not been given on Lease / Rent to anybody, till date.
4. The Electricity Deptt., Central Power Grid Corpn. Of India (A Govt. of India Enterprises) planned to erect high voltage 765 KV (HT lines) from Merrut (UP) to Bhiwani (Haryana) through our Agriculture Land. The 2 legs of the pole was installed in our Agriculture land, part of one pole bearing No.42/9 has been erected in my Agriculture land for which part payment of Rs.10,864/- vide cheque No.771970 was given / received by me by the concerned Deptt. and credited in my Canara Bank's, Sonapat account on 26.07.2011 (Copy of the Bank Statement enclosed).
5. Thereafter, I have not received any payment to the above referred cheque, till date, whereas, the other Villagers/ owners in Village Tihar Malik, Tehsil Gohana, Distt. Sonapat (Haryana) have been released the amount by the concerned Department.

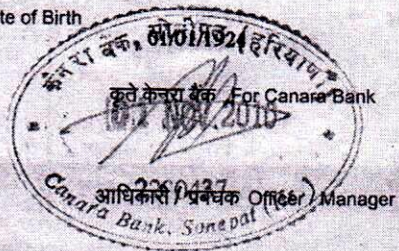

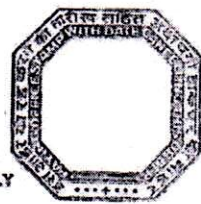
