



#### ANNEXURE "A"

### POINT WISE REPLY TO RTI:

- 1. 220KV Kishenganga to Wagoora TL comprises of one Multi Circuit TL which originates from NHPC's Kishenganga Hydroelectric project in Bandipora upto Delina in Baramula wherein it bifurcates into two Double circuit lines, one upto PDD Substation in Delina and the other, upto PGCIL Substation in Wagoora, Budgam. The said times pass through various villages of District Bandipora, Baramulla and Breigam and Pulwama.
- 2. The details of compensation paid to the landowners on account of damage to crop, fruit, and non fruit bearing trees during stringing work of the said transmission line from Village Parigam (Pulwama) to Pahroo (Budgam) are attached herewith at Annexure "B".
- 3. Khurshid Ahmad Shah, (Sr. Engr, POWERGRID, Kishenganga) may be contacted in case compensation is not paid in time.
- 4. The crop compensation forms are issued at site on account of crop damage to the concerned landowners, and the compensation amount is disbursed, as per the rates issued by the agriculture department of J&K. Also, the non fruit bearing tree damage forms are issued in the same manner and the compensation is disbursed as per the rates furnished by the forest department of J&K. Similarly, the fruit bearing tree damage forms are issued at site and compensation amount is paid as per the assessment done by the concerned horticulture department.
