Point wise reply to RTI Dated 18.08.2018:

1. Since the information pertains to third party, it cannot be provided.
2. The Fruit Bearing Trees which infringe the corridor and are damaged during the construction activities are being assessed by the State Horticulture Department and accordingly the payment is made to the affected beneficiaries.
3. Regarding adverse effects of the transmission line, it is to note here that are no harmful rays/health hazards from any of our transmission lines. The agriculture fields and fruit trees will not get affected after laying of this transmission line. However, if there is any damage to standing crops and fruit trees during execution of various works, the same shall be compensated as per the set norms of J&K Govt. Moreover, as per the provisions of Indian Electricity Act and J&K electricity act, the land outside the transmission line corridor can be useful for any commercial/residential purpose.


