As the information relates to personal nature, the disclosure of which has no relationship to any public activity or interest, it would cause unwarranted invasion of the privacy of individual and is hence denied under Section 8(1)(j) of the Right to Information Act, 2005.

The said line of reasoning has been espoused by various decisions of the CIC and The Hon'ble Supreme Court of India including the landmark decision in the case of *Girish Ramchandra Deshpande vs Cen.Information Commr. & Ors* decided on 3 October, 2012 by a Bench of K.S. Radhakrishnan, Dipak Misra, JJ
