Complete detail of the Project which has been allotted to Tata Projects limited Leh for electrification of Leh Division including material used	The query is not specific as the information sought is too detailed/expansive in nature to be given out.
Sub-contractors deployed by the Company, payments made to the contractors and material reconciliation raised by Tata Projects to the sub-contractors	Not in the scope of POWERGRID i.e. M/s Tata Projects internal record.
Tendering process detail	Tendering process is available on Powergrid website
Conditions of the contract	The information sought by you is exempted under Section 8(1)(d) of the RTI act which states as -
	"8. (1) Notwithstanding anything contained in this Act, there shall be no obligation to give any citizen (d) information including commercial confidence, trade secrets or intellectual property, the disclosure of which would harm the competitive position of a third party, unless the competent authority is satisfied that larger public interest warrants the disclosure of such information" The disclosure of information sought would undermine the confidentiality of commercial information and competitive superiority of parties to the contract.
Reason for delay in the contract	Due to various hindrances, like COVID-19, wildlife clearance, adverse weather conditions such as snowfall, rainfall etc., the contract completion period has been delayed.
