3 It is also to mention here that in the reply it is clearly mentioned that local language must be on top followed by Hindi and English.

4 it is also to mention here that according Official language Act 1963 even officers names must be written in local language that too on top of the board followed by Hindi and English.

5 The spirit of the Official language Act 1963 suggest to respect both local language and Hindi.

6. Kindly note that Chandigarh falls under Region B of Official language Act 1963. Read Official language Act 1963 and Official language Rules 1976. Copy attached

7. In spite of all these facts it is unfortunate to witness Power Grid Corporation of India Limited POWERGRID all boards are not written in local language Punjabi with top position.

8 . It is also very sad to witness that all most all the Officers do not have their name plates in Punjabi which is gross violations of Official language Act 1963. Officers names must be in three languages to facilitate common people.

Therefore my quires under RTI Act 2005 are

1..Do you adopt and follow Department of Official language Act 1963 directions and put all Boards. Sign boards. Directional Signs and Name plates of officers in three languages in the accordance with Official Language Act 1963. Official language Rules 1976

3. If no kindly provide any information regarding your plan to adopt and follow Official Language Act 1963 and put all Boards. Sign boards. Directional Signs and Name plates with local language Punjabi on top followed by Hindi and English and also put all officers and Teachers name plates in three languages with local language Gujarati on top.
