

That the applicant had filed an application before Public Information Officer- Power Grid Gurgaon under RTI Act for information on application dated 22.07.2019 but no information and intimation has been provided by the PIO within the prescribed time . Then now applicant through this application has filed an 1st appeal before the appellate authority.
2. That the RTI Act 2005 does not provide any exemption from disclosure of such kind of information and no provision is mentioned by the PIO under which he refused or not bound to provide information to applicant.
3. That the PIO has failed to follow the provisions of RTI Act in true and legal manner.
4. That it is necessary to provide information which is required by the applicant in order to promote transparency and accountability in the working of every public authority.

4. Prayer or relief sought To direct the PIO to provide all the required information sought in the initial application to the applicant with in a week.
A penalty of Rs 250 per day should be imposed on the PIO under Section 20 of the RTI Act 2005.
