If the documents are found to be meeting the eligibility criteria and subject to being found medically fit, you will be issued the offer of appointment and you will be required to join as per the offer letter.


It may be noted that no TA shall be paid for appearing in the Document Verification and/or Pre-employment Medical Examination only.
