### ORDER


The Appellate Authority, Northern Region Transmission System -3, POWERGRID has received an appeal dated 01.07.2020 from Shri Pradeep Kumar, Qtr. No. 115/B, DLW Colony, DLW, Varanasi, Pin 221004, under RTI Act, 2005 pertaining to his online RTI dated 22.06.2020.

On receipt of online appeal from the appellant, relevant papers were perused and submission of CPIO, NR-III was heard.
