Dear Sir,

I refer to letter No. PGCIL/NR3/A/20-21/25823 dated 09.07.2021 of 1<sup>st</sup> AA/PGCIL/Lucknow. In Para 2, he has mentioned that " **refereed payment pertains to transitional period from Pre-GST to Post GST regime and therefore took time in processing due to GST transitional complexities and to avoid any inappropriate transaction and tax liabilities to the parties. This the time taken is due to processing complexity and not attributable to any Powergrid Official**".

Under RTI Act 2005, I would like to have following information.

1. Information as per GST Act which came in to force from 01.07.2017, was there any provision/mention in the Act for the situation mentioned above for which PGCIL had held the payment for 4/5 months.
2. Information if for clearing payment after 4/5 months, PGCIL had received any Direction/clarification from Government on the issue/situation for which PGCIL had held the payment.

3. Information for the situation mentioned by PGCIL, if PGCIL had received any internal instruction/circular for holding the payment & releasing the same after 4/5 months. If received, in your reply please reproduce concerned lines based on which payment was held and released after 4/5 months. You may provide me copy of internal document/note sheet if any created referring internal instruction/circular for holding the payment and releasing the payment after 4/5 months.
4. Information if PGCIL has no document announced/issued by Government to deal with the situation mentioned in Para 2 of 1<sup>st</sup> AA above letter and reproduced by me in 1<sup>st</sup> Para mentioned above.
5. Information required if for this Act PGCIL had held any of its officials responsible or all concerned got their salary alright. Information required if for this decision PGCIL or any of PGCIL officials had suffered in any manner. Information required if any official of PGCIL brought out provisions of MSME Act when payment of an MSME unit was held up beyond 45 days.

I am enclosing Postal Order No. **55F 347051** of Rs.10/- favoring "**POWERGRID CORPORATION OF INDIA LIMITED**" payable at "**Faridabad**".
