These overhead charges are towards procuring labour license, compliance of PF & ESI, operational cost of contract including bank charges towards CPG, cost of manpower replacement as and when required, interest on the amount deducted from the running bills towards TDS, Security Deposit etc. and Cost of coordination / management of the labour engaged in the Contract etc. Accordingly, considering 18% GST on overhead charges of 6.5%, 7.67% has been kept as floor price.</p>
