ORDER

The Appellate Authority, Northern Region Transmission System -3, POWERGRID has received an appeal dated 13.02.2024 from Shri Rounak, H.No. 101, Darjipatti Gali Renookut, Uttar Pradesh, Sonebhadra-231217 under RTI Act, 2005 pertaining to his RTI Application dated 13.01.2024.

In view of the aforesaid appeal from the appellant, RTI application dated 13.01.2024 and information provided by the CPIO were perused and submission of CPIO, NR-III is heard. The information required at S.No. 2 & 6 is being provided by CPIO and for balance points relates to personal information is upheld. The contention of the CPIO that the requested information as sought by the appellant is relates to personal information, the disclosure of which has no relationship to any public activity or interest. Such information is exempted from disclosure under clause (j) of section 8(1) of the RTI Act, 2005, unless involve a larger public interest.

Hence, it has been directed to CPIO to provide the information i.e. sought in point No. 2 & 6 and rest information relates to personal information is upheld.
