ORDER

The Appellate Authority, Northern Region Transmission System -3, POWERGRID has received an appeal dated 16.05.2024 from Shri Hari Kishan Maurya, Maurya Meadows, NTPC Road Unchahar, Dist-Raebareli Pin 229404 under RTI Act, 2005 pertaining to his RTI Application dated 02.05.2024.

In view of the aforesaid appeal from the appellant, RTI application and information provided by the CPIO were perused and submission of CPIO, NR-III is heard. It has been gathered that it is not clear from the RTI application that appellant was seeking information for which transmission line. Now appellant vide his appeal dated 16.05.2024 clarified that he is seeking information for both the transmission lines (i.e. . 220 kV D/C Unchahar-Kanpur-1&2 and 220kV D/C Unchahar-Kanpur-3&4)

Hence it is directed to CPIO to provide available information as desired by appellant for both the transmission lines i.e. 220 kV D/C Unchahar-Kanpur-1&2 and 220kV D/C Unchahar-Kanpur-3&4. Thus, the appeal is treated as disposed-off.
