This has reference to your ONLINE First Appeal application under RTI Act received on Dt.19.02.2019 wherein you have preferred an appeal against the reply dated 23.02.2019 of the CPIO, Bhubaneswar, Odisha.

In this regard, the undersigned being the Appellate Authority, examined your First Appeal application along with the ONLINE RTI application dated 08/01/2019 forwarded by Nodal Officer RTI,CC.

On perusal of the RTI application dt.08.01.2019 and the reply dt 23.02.2019 of CPIO, Bhubaneswar, the undersigned is of the opinion that the CPIO has replied and submitted the desired information to you. However, in addition to the reply of CPIO dated 23.02.2019, the undersigned is providing following information:

01. Regarding your query no.4: Claim against the Bank Guarantee has already been lodged with the issuing Bank. But no payment has been received yet, as the case is under consideration before the NCLT.
02. Regarding your query no 6 : IL&FS Letter Dt.28.09.18 with NOC copies-18pages are attached.
03. Regarding your query no.7: Additional letter of correspondences Dt.20.08.18 -1page, 11.10.18-1page, 04.10.18-1page, 20.02.18-1page & copy of e-mail Dt.01-11-17-10pages between POWERGRID & IL&FS are enclosed. One letter Dt NIL addressed to GM-RE, POWERGRID by Sh Amar Ballav Sahu & others are also enclosed-3pages.

Further, in the First Appeal application dated 19.02.2019, you have raised fresh query. In this regard, the undersigned would like to inform that the fresh query raised in the First Appeal is beyond the jurisdiction of the First Appellate Authority, as such the same cannot be entertained. However you may file fresh RTI application against the fresh queries.

The appeal, accordingly, stands disposed of.
