But, the CPIO has given me Information only on postal and suppressed many data through hard copy basis. What is the reason behind it. Kindly give the information through my e-mail. 2) On Sl. No.1, I begged the information about the terms & conditions regarding payments of Erection Sub-Contractors of I L & F S ECC Ltd, but the C.P.I.O on his Letter Ref.No.C-46901-L795-3/LOA-II/2498, Dt.28/4/2008 given me incomplete Data which reflected on his suggestion to see 7.0 (Terms of Payment) which indicate to see again Clause No.8.0. But, on Clause No.8.0 (Page 9 of 13) it is seen large portion of this page intentionally concealed, only 7.5.4 after 2 line on photo copy the information cut to tampering the data. If it is given through e-mail that thing may not happened. So, I request you to give me full data both through e-mail & postal. 3) On Sl. No.2, I wanted the information about the payments in invoice wise but the C.P.I.O have given me the payment list of Package-B (Supply Bill Dt.27/5/13 & Erection Bill Dt.05/9/14) & Package-C (Supply Bill Dt.12/9/13 & Erection Bill Dt.05/9/2014). After that dates any other payment(s), B.G release to I L & F S ECC Ltd made or not, kindly provide this/these in both soft & hard copy.</p>
