This has reference to your ONLINE First Appeal application under RTI Act received on Dt.11.04.2019 wherein you have further appealed against the reply dated 20.03.2019 of the CPIO, Bhubaneswar, Odisha.

The undersigned being the Appellate Authority, examined your First Appeal application along with the ONLINE RTI application dated 19/02/2019 forwarded by Nodal Office RTI,CC.

On perusal of the RTI application dt.19.02.2019 and the reply dt 20.03.2019 of CPIO, Bhubaneswar, the undersigned is of the opinion that the CPIO has replied and submitted the desired information to you. The undersigned would like to add the following additional information:

01. Copy of your ONLINE RTI application is being enclosed for your reference. You have neither mentioned anything about e-mail reply nor hardcopy. However CPIO has provided details as per file size restriction in ONLINE RTI portal & also forwarded hardcopy for your reference.
02. You have been offered to inspect the complete Contract Agreement copies. Additionally, CPIO has also provided LOA portions showing payment terms for your convenience. Again as requested by you main portions 13pages of each Contract agreement is enclosed.
03. Complete payment reconciliation statement with respect to the packages showing all invoice-wise payments has already been provided by the CPIO. However as specifically requested, this is for your information that "No payment has been made to M/s IL&FS for Jajpur-B-Supply package after 27-05-13, Erection package after 05-09-2014 & for Jajpur-C Supply Package after 12-09-2013 & Erection package after 05-09-2014.


