I, Kollapaneni Seshaiyah, S/o. Late Laxmaiah, Age: 66 years, Occu: Retired Govt Employee, R/o.H.No.6-1-303, V.D.O's Colony, Khammam Municipal Corporation and Dist, submit the following few lines for your kind consideration and for taking necessary action.

That, I am a retired Govt. employee and resident of H.No.6-1-303, V.D.O's Colony, Khammam Municipal Corporation and Dist.

That I am the owner of agricultural land measuring Ac.1-22 gts out of Sy.No.210 of Papatapally Village, Raghunathapalem Mandal of Khammam District.

That I raised a mango garden in the said land about 20 years back and in between mango trees I also planted Lemon, Neem, Teak wood, Coconut trees and other trees in the borders of the land. I used to raise Green gram, Red gram, Black gram in between the mango trees and I used to get an income of for Rs.2,00,000/- per year on the mango garden and on the crops.

That in the month of March, 2015 I received a letter from Power Grid Complex, Budidempadu vide its No.1753, Dated: 10-03-2015, wherein I was informed that my part of land is required by the Power Grid Corporation, Vizag, for erecting a tower for which purpose a four legs foundation has to be made vide location/section 9/0 and I gave a reply immediately on 24-05-2015.

That I received another notice dated Nil, vide its No.987.
