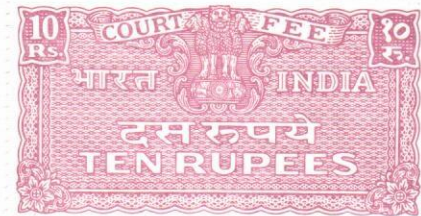

Particulars of the Information Required:

- i) The Power Grid Corporation has provided Guest House Accommodation unauthorizedly to the following Guests and the cost of accommodation and food was also borne by the corporation.
 - a) Mr.Anindya Das Gupta, O/o.A.G.Office, A.P. for 42 days for 6 members from 1-7-2018 in Room No.1 and 4. Please furnish the details of the accommodation cost and food cost bore by the corporation to the said guests.
 - b) Mr.M.S.Subramanya, IAAS, O/o.PDCA &MAB from 20-4-2019 to 13-6-2019 for 4 members in Room No.2&3. Accommodation cost and food cost was borne by the corporation unauthorized manner.
 - c) Mr.A. Radha Krishna, Chief Manager-HR, HQ,RHQ,Sec'bad and his wife Mrs.A. Nirmala, ESGR-I, HRM,RHQ,Sec'bad are residing in one house No.Flat No.219, The Land Mark Apartment, Kapra, Hyderabad and both are drawing 100% HRA, contrary to the rules of eligibility(i.e. instead of 60%+40% or when both couples are working one of the employee can draw 100% HRA but not by both persons). Why the deviation of HRA rules for these persons.

Another couple Mr.Sita Devi and Venkatrao was also worked earlier in the company. For them the company paid HRA only to one person (Mr.Venkata Rao) to the extent of 100%HRA.

Mr.B.S.Rao who sanctioned to 100% HRA to both couples of Mr.A. Radha Krishna A. Nirmala was also sanctioned earlier only 100% to one person only when the couples are working in Bangalore, contrary to the rules the same person sanctioned 100% HRA to both couples. The fact of the same was also disclosed by him.

Therefore, I request you to please furnish the information of the same to the earliest possible.
