**ORDER**

**Grounds of Appeal:**

Being aggrieved by the information provided by the CPIO, POWERGRID, SR-I, Secunderabad, vide his letter No.SRTS-I:RTI-71:2576:2019 Dt:27.09.2019 against the Request of the Appellant vide on-line application No.PGCIL/R/2019/50379 Dt:31.08.2019, the Appellant has filed this on the following grounds:-

- (i) The Appellant has stated that CPIO Office had not provided the requested information for the RTI Request Ref.No.PGCIL/R/2019/50379 Dt:31.08.2019.
- (ii) The Appellant further stated that he has not been provided the requested information for the Appeal vide reference No.FA/2019-20/314 Dt:11.11.2019.

**Appeal Reference No.FA/2019-20/314 dated 11<sup>th</sup> November 2019 (received on 13.11.2019)**

On receipt of the Appeal No.FA/2019-20/314 dated 11.11.2019, CPIO, POWERGRID, SR-I, Secunderabad was called and the grievance made in the Appeal, was explained to him. He furnished that the RTI request was replied vide letter No.SRTS-I:RTI-71:2576:2019 dated 27.09.2019.

CPIO further stated that he could not provide the requisite information as the details sought are of third party information and disclosure of such information as per Clause 8(1) (d) of the RTI Act, 2005 is exempted. Hence not provided.

**Decision:**

I have examined and sifted the documents connected in the matter and dispose of the Appeal as under:

- a) The Appellant had filed an Application dated 30.08.2019 seeking following information under the Right to Information Act, 2005:  
"IN ANDHRA PRADESH, EAST GODAVARI DISTRICT, GADARADA VILLAGE IN KORUKONDA MANDALAM, KALAVACHERLA REVENUE – SEETHARAMAPURAM VILLAGE IN RAJANAGARAM MANDALAM, MURARI VILLAGE IN GANDEPALLI MANDALAM, DUE TO COVERAGE OF HITENTION WIRES AND TOWERS HOW MUCH COMPENSATION GIVEN TO FARMERS AND TENANTS AND ALSO GIVE THEIR SURVEY NUMBERS AND FARMER NAMES. AND ALSO IS THERE ANY EXTRA COMPENSATION GIVEN TO FARMERS DUE TO DAMAGES OF THEIR FIELDS, GIVE FULL DETAILS....., AND ALSO GIVE PENDING COMPENSATION DETAILS LIST"
- b) The Reply provided to the Appellant vide letter dated 27.09.2019 is found to be satisfactory, as time and again, the Commission and the Apex Court advise that the RTI Act should not be allowed to be misused to become a tool to obstruct national development and integration as to destroy peace, harmony and tranquility among its Citizens.
