

My client states that originally the notice schedule mentioned property in S.No. 91/2 Total extent Ac. 1.72 cents situated in 155 Kamma palle revenue village of Yadamari Mandal belongs to Late Smt. Bandla Kamamma w/o Late Bandla Narayana Reddy who got **joint 1/2 share** and K.V. Parasurama Reddy and Late K.V. Jayarama Reddy who are sons of Late K. Venkata Reddy got **joint 1/2 share** in the notice schedule mentioned property and jointly enjoying the property without any division by mates and bounds as per their convenient.

4 legs pole in the notice schedule mentioned property which is joint property of my client and No. 3 of you to take transmission Line through the said pole and some land was occupied by the said pole for which the Central Government granted damages/compensation to the owners of the lands i.e. to my client and No. 3 of you. But No. 1 of you without any proper enquiry about the notice schedule property by colluding with No. 3 of you gave a false report to No. 2 of you as if No. 3 of you is the absolute owner of the land covered under the said 4 leg pole to get compensation though the notice schedule land is joint land without any division between co-owner by mates and bounds. Further the boundaries shown to the notice schedule property is to the entire total extent Ac.1.72 cents in S.No. 91/2. Therefore No. 2 of you have no right to grant entire compensation to No. 3 of you for which she is entitled to only 1/4<sup>th</sup> share where as my client is entitled to 3/4<sup>th</sup> share in the compensation. Therefore No. 2 of you, not to grant total compensation to No. 3 of you for which she is not entitled to since the entire land is joint land and there is no division between the parties by mates and bounds till today. Further my client recently came to know that No. 3 of you approaching No. 2 of you and falsely claiming total compensation to get wrongful gain and to cause loss to my client for which she is not entitled to.

5. I therefore call upon you on behalf of my client to grant 3/4<sup>th</sup> share of compensation amount for which he is entitled to and to grant remaining 1/4<sup>th</sup> share to No. 3 of you for which she is entitled to. Otherwise if No.2 of you grant total compensation to No. 3 of you for the joint land, my client will take necessary legal steps against you as per law and in such event you are held liable for all the costs incurred by my client including this notice charges of Rs. 2,000/-. Please avoid litigation.

This has reference to your above said letter dated 11.03.2019 on behalf of your client

Shri T. Muniraja Reddy S/O Late T. Sesha Reddy, residing at D.No. 5-866, S.C.B street, Santhapet, Chittoor, AP.

In this regard this is to inform you that Power Grid Corporation of India Limited (POWERGRID), a Govt. of India Enterprise, a Central Transmission Utility, is a pioneer in Construction and Maintenance of EHV Transmission Lines and Substations up to 1200 kV in the Country. POWERGRID have been entrusted from Ministry of Power, Government of India under Section 68(1) of Electricity Act, 2003 for establishment of +/- 800KV HVDC Raigarh (Chattisgarh) - Pugalur (Tamilnadu) Transmission System to evacuate 6000 MW power from Chattisgarh to the power deficit Southern States including State of Andhra Pradesh. Public Notice has been issued in local NEWS papers on 08.04.2017 with the details of Villages, Mandals and Districts through which the said transmission line shall pass through, *inter alia*, in the State of Andhra Pradesh.

Tower foundation, erection and stringing works has been carried out with the finalised route alignment.

As per the information provided by your legal notice it has been observed that 3/4<sup>th</sup> compensation related to the survey no: -91/2 of 155 Kammapalle revenue village, Yadamari mandal, Chittoor district for tower foundation area as per the compensation rate issued by the district collector. But One Smt K.Vasantha W/O C. Krishna has claimed for 100% compensation on the schedule property for the area utilised during tower construction works.

The issue has been taken up to the Mandal Revenue officer, Yadamari and discussed with MRO in the presence of your client on 18.09.2019. Since there is a dispute in the lands of the survey number 91/2 mentioned the payment has not been paid still date and it is kept on hold. Once clearance from the Mandal Revenue officer, Yadamari is received, payment would be processed and paid online.


