**A. Diploma Trainee(Electrical/Civil)**

The written test is of objective type in 2 parts viz Part-I and Part-II consisting of 170 questions to be answered in 120 minutes.

Part-I consists of Technical Knowledge Test of 120 questions having specific questions of respective discipline and Part-II consists of Supervisory Aptitude Test with 50 questions on Vocabulary, Verbal Comprehension, quantitative aptitude reasoning ability, ability to determine data sufficiency, interpretation of graphs/charts/tables, numerical ability etc. All questions carry equal marks (1). Wrong and multiple answers would result in negative marks of ¼.

**B. Jr Officer(HR) Trainee**

The written test is of objective type in 2 parts viz Part-I and Part-II consisting of 170 questions to be answered in 120 minutes.

**Qualifying criteria in Written Test:**

**General Guidelines**
