On the Raigarh-Pugalur transmission line set up by the Power Grid Corporation of India Limited, large scale works were carried out near Kambhamvari Palli (village) ,Sodam (Mandal), Chittoor (District) till 2019 and 2020. There is a crop of banana trees in the order of hightension wires in the farm land of our mother V Amaravatamma and Father V Seetharami Reddy of our family between tower number 356/2 and 356/3 in this order 350 trees were uprooted and destroyed while working. Hence, we gave notice to the authorities and for claim of compensation against the loss born by you (We have sent the pictures to them through the WhatsApp and over the phone and I have all proofs preserved with me and will provide call recordings if they have any doubts) and so far we have not been given any notice to the banana trees as we have	As per the available records total crop and tree compensation amount of Rs. 4,96,664/- paid to Smt. V Amaravathamma, w/o V Seetharami Reddy out of which Rs.52,479/- for the crops damaged during the construction works.
