ORDER

Grounds of Appeal:

Being aggrieved as CPIO has not responded within the time limit to his RTI query vide ref no. PGCIL/R/E/22/00036 dated 27.01.2022, the Appellant has filed this appeal on the following grounds:-

- (i) The Appellant has stated that CPIO Office had not provided the requested information within the time limit for the RTI Request PGCIL/R/E/22/00036 dated 27.01.2022 (Received on 28.1.2022)

On receipt of the Appeal ref No. PGCIL/A/E/22/00009 dated 10.03.2022, CPIO, POWERGRID, SR-I, Secunderabad was called and the grievance made in the Appeal, was explained to him. He furnished that the RTI request was replied vide letter No. SRTS-I: PMD: RTI--0-507 dated 25.02.2022 through speed post & same was uploaded in RTI Site on 25.2.2022

From the above facts, it is clear that Appellant would have received the information by 25.02.2022 itself. However, a copy of the reply dated 25.02.2022 is enclosed for ready reference.


CPIO further stated that, there is no delay in furnishing the information to the applicant as the request dated on 27.01.2022 (received on 28.01.2022) vide request ref. no PGCIL/R/E/22/00036 and reply was sent to applicant vide letter ref no. SRTS-I: PMD: RTI- 0- 507 dated 25.02.2022 through Speed post and same was up-loaded in RTI portal on 25.02.2022. As the information sought by the applicant is available in our site office, getting and compiling the requisite information from our site office took little bit of time. Hence the query was replied on 25.02.2022 which is within the time limit of Thirty Days from the date of receipt of the request, as per the Section 7 of the RTI Act.

Decision:

I have examined and sifted the documents connected in the matter and dispose of the Appeal as under:

The Appellant had filed application dated 27.01.2022 seeking the information under the Right to Information Act, 2005. I found that there was no delay in responding to the query of the applicant by CPIO, who has provided the information vide letter dated 25.02.2022.

Hence, the Appeal is disposed of accordingly.
