ORDER

BACKGROUND:

The Appellant, Shri Grirish Gajjela, has preferred this appeal bearing ref. no. <u>PGCIL/A/E/22/00055</u> dated 24.12.2022 u/s 19(1) of RTI Act and received by the office of First Appellate Authority on 24.12.2022. The Appellant's grievance is that the CPIO has not responded with the requested information under the RTI request bearing Ref. <u>No. PGCIL/R/E/22/000385</u> dated 23.11.2022 within the time limit. Hence, this appeal.

GROUND OF APPEAL:

(i) The Appellant in his appeal has stated that the CPIO Office has not provided the information requested by him under his RTI request bearing Ref. No. PGCIL/R/E/22/000385 dated 23.11.2022 (Received on 23.11.2022) within the prescribed time limit of 30 days from receipt of request.

OBSERVANCE:

On receipt of the Appeal bearing Reference No. PGCIL/A/E/22/00055 dd. 24.12.2022, CPIO, POWERGRID, SR-I, Secunderabad was called upon and the grievance made in the Appeal was stated to him. The CPIO informed that the information has already been sent by his office.

- CPIO further stated that, there was no delay in furnishing of the information to the applicant requested by him vide his request Ref. No. PGCIL/R/E/22/00385 dtd.23.11.2022. The reply was sent to Applicant vide letter bearing No. SRTS-I/RTI/Online/378 dtd. 05.12.2022 through speed post (EN830978888IN) and the same had also been uploaded in RTI Portal.
- 2) The RTI request reply dd. 05.12.2022 was returned unserved by the Postal Department and received by the office of CPIO on 09.12.2022 stating that no such person is available on the given address.
- 3) Thereafter, the Applicant had contacted the office of CPIO, POWERGRID, SR-I on 27.12.2022 and had provided his email id for receipt of information requested by him. Accordingly, the RTI reply was attached and mailed to his email address on 27.12.2022.
- 4) Further, the Applicant, Shri Girish Gajjela, vide his email dd. 13.01.2023 has acknowledged the receipt of the RTI reply sent through email dd. 27.12.2022. Copy of the same is enclosed herewith for ready reference.

The Appellant had filed application dated 23.11.2022 seeking the information under the Right to Information Act,2005, and the CPIO, has duly provided the requested information vide letter dated 05.12.2022 well within the prescribed time limit of 30 days u/s 7 of the RTI Act.

I have examined and sifted the documents connected with the matter and find no delay on the part of the CPIO in furnishing of the requested information within the time limit.

DECISION:

The Appeal is accordingly disposed of.
