The following additional information is requested. 1. PF settlement: My present employer, M/s Bharat Dynamics Limited maintains and manages PF through PF Trust like M/s Powergrid. Accordingly I have requested for the PF from PGCIL PF Trust to BDL PF Trust. Hence PF is not part of final settlement. 2. Understood that I have resigned Powergrid on 01/12/2018 and served for 11 days till 11/12/2018. Please provide the payment details of Rs 11,346/- with bank transaction reference (UTR No) and date 3. Gratuity: As per the DPE guidelines, in case of transfer of employment from one PSU to another PSU through proper channel, the candidate is eligible for the transfer of gratuity from the previous PSU employer to present PSU employer. Recently an employee has joined BDL from Powergrid through proper channel, his unused HPL's were transferred to BDL, and accordingly, my unused HPL's also shall be transferred to BDL.
