
Sir,

Under the RTI Act, kindly provide the following information:

- 1) The original survey with line map for the proposed Transmission line for 10 Kms on either side of land owned by Reliance Industries Ltd (Your proposed tower location –

- 101) indicating the locations originally identified for power transmission towers with details of land;
- 2) The details of all the Changes made to the above original transmission line / tower locations with reasons for making such changes;
- 3) Types of towers – C Type, D Type in the 10 kms mentioned stretch on either side of your proposed tower location 101.
- 4) Details of the land where the proposed transmission line / towers are to be embedded between the mentioned 10 kms stretch on either side of the above referred land owned by Reliance Industries Ltd – your proposed tower location 101 with names of the owners of such land.
- 5) Guidelines specified by Railways & Power Grid Corporation of India with respect to installation of towers / transmission line crossing with respect to railway tracks in reference to towers 99, 100, 101, 102 & 103.
- 6) Drawings with technical specifications submitted by Power Grid Corporation of India with respect to towers 99, 100, 101, 102 & 103 along with approval from Railways.
- 7) Details of requests for relocation and objections, if any, received from the landowners or general public to the drawing of the line and embedding of the towers in the above mentioned stretch.
- 8) Details of any relocation of towers from the original plan due to presence of any petroleum retail outlet (PSU / Private) from Tuticorin to Dharmapuri Stretch.
- 9) Details of notices issued, if any, to the owners of the land where it is proposed to install the power transmission towers between the above mentioned stretches with copies of such notices).
- 10) Details and Copies of complaints, if any, received against the officials of the Power Grid Corporation Ltd., who were/are involved in the laying of the above transmission line with details of action taken, if any.
- 11) Details of litigation with case numbers of the respective Courts, if any, on-going and concluded concerning the drawing of the above transmission line and the installation of power transmission towers on the above route, i.e. from Tuticorin to Dharmapuri with copies of the proceedings.
