Point wise Reply to RTI Query by M/s Reliance Industries Limited pertaining to details of Tuticorin –Dharmapuri (New Salem) 765 kV Transmission line (Part-II) under Construction by POWERGRID.

Query No.1:Your reply letter Ref:SR-II/RTI/F-250/2014/31980 dated 5<sup>th</sup> Aug 2014:In reply to Query No.2 it is stated that, "During execution of works at site due to various factors like techno economical/statutory clearance requirements, soil conditions etc fine tuning of the route will be necessitated. On completion of the entire works, comprehensive approval for the entire constructed route will be obtained from the competent authority. The required details will be available on completion of entire works only as the works are still under progress"-It is difficult to believe that a public sector organisation like yours has undertaken such a large project with huge financial and third party implications without any initial approval. It cannot be accepted that the approval will be obtained only on completion of the entire works. There must be a process of initial approval and approval for every subsequent change made. We, therefore ,seek such initial approval accorded for carrying out the work of installation of towers on this route and approval for every change made thereto till date with relevant details , annexures and attachments.

**Reply**: Initial approval accorded by the competent authority is available and this document contain proposed transmission line route alignment drawn on Survey of India map. Since reproduction of Survey of India Map is not permitted, the same can be viewed by visiting our ERODE office with prior appointment. The address of Erode office is furnished below.

During execution of works, due to various factors like technical/ statutory clearance requirements, tower spotting constraints, soil conditions etc, fine tuning of the initial route will be necessitated in few locations. For such minor changes, comprehensive approval for

the whole constructed route will be taken from Competent Authority on completion of entire work. The sought information is presently not available considering that works are still under progress and comprehensive approval will be taken only on completion of work.

Query No.2: In reply to query no.4, it is stated that "Data like details of land with names of the owner covered along the route of the transmission line are not being collected and as such not available." These details were sought in respect of the towers embedded in the 10km stretch on either side of our site. The reply given by you cannot be accepted on the face of it. It is unbelievable that the Corporation does not have the details of the land and owner of the land where the tower, which is an asset of the Corporation, is or is to be embedded. You are therefore once again requested to provide these details.

**Reply:** There is no land acquisition involved in the process of identifying land and placement of tower. The land where the tower is located continue to be under the ownership of the land owner, even after placement of towers. Hence generally details of land owners of tower locations are generally not collected and notices are not issued. However, if there are any standing trees/crops available in the proposed tower location, then details of the owner of land for that particular location will be collected and notices served to the owner for the likely damages to his/her trees/crops.

The details of land owners in respect of the towers (wherever notices were issued for the likely damages) embedded in the 10 kms stretch on either side of Loc. No 101 is enclosed as Appendix A

Query No.3: Your reply letter Ref.SR-II/RTI/F-250/2014/31980 dated 5<sup>th</sup> August 2014: Reply to Query no.6. Approval letter from Southern Railways has been enclosed. Approved drawing No.SA/E.31/II/12-13/39 as given in letter from Southern Railway Ref.RBC.14.03022014-2No SA/E.31/II12-13/39 dated 3<sup>rd</sup> Feb 2014 not provided, same may be given. Charges, if any, applicable shall be paid by us.

Reply: Copy of the approved drawing enclosed as Appendix B.

Query No.4: Your reply letter Ref.SR-II/RTI/F-250/2014/31980 dated 5<sup>th</sup> Aug 2014. Reply to Query no.7. Reply is specific only to objections. It does not state any request received for relocation of the proposed transmission line. You are therefore requested to provide the details of "all requests received for relocation" from the owners of the land where the towers are embedded or are to be embedded. Proposed tower location in land belonging to Reliance Industries limited is given as 102. In all correspondences we are of the understanding that the tower location is 101. Kindly reconfirm.

**Reply:** Copies of all the requests received for the entire transmission line except the one received from your organisation for relocation of towers /alignment of route away from the owner's land for the entire transmission line route are furnished as Appendix C


Reply: Reply already furnished against Query no.4 above.

Ouery No.6: Your reply letter Ref.SR-II/RTI/F-250/2014/31980 dated 5<sup>th</sup> Aug 2014: Reply to Query No.10.In your reply to our query, you have taken a stand that you are exempted from disclosing the information under section 8 (1) (j) of the RTI Act 2005, which is untenable & unsustainable under the RTI Act 2005 itself since we are not seeking any personal information. Our query is seeking the details and copies of complaints, if any received against the officials in discharge of their official duties of the Powergrid Corporation Ltd, who were /are involved in the laying of the above transmission line with details of action taken, if any to be furnished. We are surprised to see your reply taking shelter under section 8(1)(j)of the RTI Act 2005. Our query referred above cannot be construed by any stretch of imagination that we are asking for the personal information which has no relationship to any public duty. In other words, our query specifically sought the details of complaints while discharging their official duties in laying of transmission lines. It is needless to state that your reply is grossly misled placing reliance on section 8(1)(j) of RTI Act 2005. Hence we request you to disclose the information with regard to the copies of complaints received and with the details of action taken against your officials in relation to laying of the transmission lines.

**Reply**: It is informed that the information sought against query no 6 mentioned above falls under the category of exemption from disclosure as per clause no 8(1) (h) as well as 8(1)(j) of RTI Act2005 and hence can not be disclosed.
