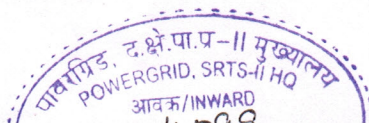

Sub: informations from you - - Producing before the Magistrate.

Your summated non individualised reply Ref: SR-II/RTI/F-253/2014/32358 dated 13.8-2014 addressed to MK Krishna who is myself in reply to my RTI application received by you on 15-7-2014.

I am pleased to thank you for respectfully sending me your reply bearing Ref: SR-II/RTI/F-253/2014/32358 dated 13.8-2014 that does not mention the subject of the application at all. Only I and you can interlink it to the application because you have concealed it from the sights of all those who would see it ; Your style of correspondences with me appears to be objective of giving a protective blanket cover to the ineligible illegal ones of your Grid and deny legitimacy and allow the ineligible ones to continue their illegal trade under the protected cover of your blanket that has a large field that is amply interned with fine fertilizers and mature manures for the plants of illegal trade to grow flush and stay stand as a tall tree to generate illegal and unhealthy fruits in the coming times that no one knowing it as illegal and or unhealthy would want to consume leave alone consuming.; if those fruits are catered stealthily and consumed , those who consume with ignorance about its unhealthy and illegal quality with the impression that those are nutritious and healthy would suffer grave injuries when it becomes absolutely necessary to cut and fell the tree on to the ground uproot it and fetch far away the debris or timber into oblivion where it would be set afire when the flames and smoke would raise high in the Air and gradually dissipate into the abundant air beyond sights and goes into oblivion once and for all ; with this I hope your sense understands that Powergrid shall not have its rosy RHQ building for use or occupancy even and if occupied illegally the tenants or occupants there would be evicted and the RHQ

building would have to be razed down onto the ground to do the next as that of the tree that is mentioned here aback; still after the ground would have to dug deeper than it was dug to extricate what all is immersed in it as though exhuming an interned dead body for post mortem for determining the cause of death of the life that had departed from the interned body; the difference between the exhumed body and the felled building and extricated stuff would be that the exhumed body would be taken into safe custody to the hospital for conducting post mortem on it to detect the thitherto unknown cause of death of the life of the body while alive and after determining the cause of death the exhumed body would be restored to its rightful claimants or the concerned authorities themselves would rebury it in a proper grave yard while the felled building and the extricated stuff would be dissipated into oblivion as debris scattered on different areas of ground.

Further it is to state that the quality of the contents of your reply in citation herein above has given scope for the following:-

- a) Complain-against it with more than one, the one being your executive director seeking punishments to the quality maker.
- b) The one other for complaining against would be State Bank of Mysore that had has securitized your contract by furnishing its guarantee by taking risk on its part on behalf of the contractor seeking institution of criminal proceedings against the Employer Powergrid the Contractor KBR Infratech Ltd and the Fraud Encouraging Guarantor State bank of Mysore too and seeking it to stop further or the balance of construction.
- c) Move the Honourable High Court of Karnataka thru' legal proceedings and administrative annals.
- d) Release to the public print media , the audio visual broadcasters etc when the Hobnourable high court of Karnataka would take Suo motto notice and serve notices upon all the three mentioned at b) here on to appear before it.
- e) Complain to the central bureau of Investigation.
- f) Go in appeal to the 1st appellate authority of Powergrid.
