Sub: Your appeal in respect of the replies given by CPIO on 13.08.2014 and 24.06.2014 under RTI Act

Dear Sh M.K Krishna,

This has reference to your appeal Ref : 2-apeel/fresh.no aksn.13/8 and No/F-245/Apeel-I REF:3/fresh/akshn-ed-19 received in this office on 11.09.2014. The RTI applications submitted by you and the corresponding replies furnished by CPIO on 13.08.2014 and 24.06.2014 have been reviewed by this office. As per the provisions of the RTI Act 2005, specific information which is available in the office as per records only can be provided by the CPIO. In your RTI application REF:3/fresh /akshn-ed-19 received by CPIO on 15/07/2014, you had asked about the actions taken by Executive Director/POWERGRID/SRTS-II on few points cited in your letter dated 19.05.2014. Since no action was taken on those points mentioned in your letter, as it did not warrant any action, the CPIO had rightly replied that no records are available regarding action taken on your queries. As regards the action taken by Manager (C&M) on your letter dt 19.05.2014 addressed to her, it is understood that Manager(C&M) did not receive any letter dt 19.05.2014 as referred by you. Accordingly, CPIO did not get any record regarding any action taken on your said letter and he has communicated the same to you.

In your RTI application dt 19.05.2014, a large number of questions, numbering more than sixty, were asked and the information required / documents sought for inspection had also not been specific. This would have resulted in disproportionate diversion of resources of the public authority. Hence CPIO in his reply had requested you to clearly specify the information/documents required. You may clearly specify the information required/document sought for inspection while submitting your application to enable CPIO to provide the required information.
