## REPLY TO THE RTI APPLICATION FROM Shri S.NALLAIAH SOUGHT VIDE LETTER DT. 29.10.14

- 1) How many acres of land have been acquired for the Power Grid Corporation sub-station being established on Ettayapuram-Tuticorin four way roads?
  - 113.35 Acres
- 2) Whether the land has been acquired after the press notification for land acquisition issued by Revenue Divisional Officer, Kovilpatti or acquired through court - Details
  - Acquired through orders of Madurai Bench of Honourable Madras High court vide W.P 14739 of 2011
- 3) If acquired through court how much compensation is paid? Details of persons received payment such as Name, Address
  - The compensation is yet to be fixed by the arbitrator appointed by the court
- 4) As per the press notification it is understood that the acquired land is declared as excess land distributed to farmers. If so, whether no objection certificate is issued by Asst.Commissioner (Land Ceiling), Tirunelveli
  - No information is available with POWERGRID in this regard.
