Sub: Right to Information Act 2005 – Request for documents in relating to land acquisition – Reg.

The following lands mentioned in the schedule was acquired for the purpose of Power Transmission System under National Power Grid Power Corporation of India and the lands have been acquired for the purpose of establishing and aligning the 230KVA double Circuits Kalpakkam to Siruseri and the impact on the said purpose our land has been acquired.

The suit filed by us was withdrawn as you have agreed to compensate us. In spite of withdrawal of the suit, the compensation was not paid. Therefore, we would like to know the following matters for proceeding further.

The purpose for which the land has been acquired and the extent of the land in usage and the impact value arrived on the date of acquired property. The extent of the property acquired pertaining to the land which was classified as Patta land.

I am herewith enclosing a crossed Postal Order No.11F 580782 dated 05.11.2014 for an amount of Rs.10/- drawn in favour of Power Grid Corporation of India Limited as requisite fee for furnishing the certified information under Right to information Act 2005.

Therefore, you are hereby called upon to produce the documents referred pertaining to the matter referred above so as to enable us to seek necessary compensation for the land acquired, as we are not able to proceed with the project pertaining to the land mentioned in the schedule hereunder.

Item No.I:


